**ELIGIBILITY: ALL COMPETITORS:** (1) each competitor must be registered with the sanctioning body for this show and to meet this requirement, he/she can register at check in. The cost is \$60. (2) Each competitor must be an amateur in good standing. **KS State Show is open to residents of KS and any state that borders KS. Land of OZ is open to any amateur competitor.**

**MASTERS MEN AND WOMEN:** Each competitor in these Divisions by May 1<sup>st</sup>, 2010 must have reached his/her birthday for that division and (2) must provide proof of age with birth certificate, driver's license or state I.D.

**RULES: NO** dream tan allowed in venue (**NO Exceptions**). **Spray Tan available for a fee by appointment only.** Any competitor who competes at judging must participate in evening show. Men, solid color posing suits at judging and evening show. Ladies, solid color posing suit at judging, however multi-colored suits may be worn in the evening show. No jewelry will be worn during judging; however wedding rings are acceptable to wear. Ladies may wear earrings and/or hair ornaments at the evening show only. All athletes must exhibit good sportsmanship at all times (including awards presentation). NO one will be allowed backstage and in pump up area (weight room) except officials and competitors. **NO EXCEPTIONS!** **POSING & MUSIC:** Competitor must provide a CD for the evening posing routine – up to 90 seconds of music (turn in at weigh in). Your music must be in a case and labeled with your name. Music of poor quality, with more than one song and/or with vulgar or obscene lyrics will not be played and will be replaced by house music. **NOTICE REGARDING POSING ROUTINES:** If there are 75 or more competitors in the entire show. The head judge can restrict posing routines to the top 5 in each class.

**TICKETS: NO** refunds on entry fees and/or any tickets purchased for any competitor eliminated and/or their attendees.

**Awards: ALL DIVISIONS, ALL CLASSES:** 1<sup>st</sup> thru 5<sup>th</sup> receive custom designed Medal. Each division winner receives an overall award. The figure overall winner receives a Mountain Bike. **Every Athlete that enters the show receives the following: Custom Designed Medal**
